Articles present an authoritative understanding on a range of topics, including basic mechanisms, diagnosis, treatment, and prognosis of heart and blood vessel disorders for clinicians and basic scientists. Topics offer insights into all aspects of cardiology, ranging from arrhythmias to vasculopathies.

### **Guidelines for Contributing Author**

TCM is a review journal that does not publish original studies. Unsolicited manuscripts containing original research results will be rejected without review.

### **Length and Format**

Your manuscript should be approximately 3000-5000 words (8-10 pages typed double-spaced), including references, tables, figures, and figure legends. Limit tables plus figures to eight. Additional material can be submitted as supplementary files and will be placed on the website. See Supplementary Material. We can accept most word processing formats (ideally Microsoft Word or WordPerfect).

Most formatting codes are removed or replaced when we process your article, so there is no need to use excessive layout styling. Please do not use options such as automatic word breaking, justified layout, double columns, or automatic paragraph numbering (especially for numbered references). Do use bold face, italics, subscripts, superscripts, etc., as appropriate. Use only standard abbreviations.

### **Tables**

When preparing tables, if you are using a table grid use only one grid for each separate table and not a grid for each row. If no grid is being used, use tabs instead of spaces to align columns.

### **Illustrations**

We welcome the use of illustrations, and prefer submission of figures via digital files. If hard copies are required for clarity, they will be requested by the Elsevier copyeditor.

You will receive one complimentary page of color illustration (to fit suitably on an 8<sup>1</sup>/<sub>2</sub>" × 11" page). If you wish to submit more than one page of color with your article, you will be charged for the cost of reproduction (\$650 for the first figure outside the complimentary page; \$100 for each additional color figure). At no cost to authors, additional color figures may appear in black and white in print and in color online.

### **Electronic Artwork Guidelines**

Videos are encouraged. For full artwork and multimedia guidelines, see <http://www.elsevier.com/locate/artworkinstructions>. Preferred formats are TIFF, EPS, and PDF. MS Office files (Word, PowerPoint, Excel) are also accepted, provided the following points are adhered to: (1) Minimum acceptable resolution is 300 dpi for halftones, 500 dpi for line art/halftone combinations, and 1000 dpi for line art; (2) Do not reduce or enlarge images after placement in the MS Office application, as this can lead to loss of image quality; (3) Use only truetype fonts (preferred fonts include Arial, Courier, Helvetica, Symbol, Times).

Provide all illustrations as separate files. Artwork should be numbered according to sequence in the text. Captions for figures, schemes, and plates should be included after the references. Be sure illustrations are referred to in the text.

Use CMYK color coding instead of RGB to ensure accurate reproduction of colors.

### **References**

This journal uses a numbered Vancouver style. The best source is here: <http://www.ncbi.nlm.nih.gov/books/NBK7256/?amp>. Number references in the order in which they are cited in the text. Include references to unpublished material or personal communications in the text in parentheses.

### **Data References**

This journal encourages you to cite underlying or relevant datasets in your manuscript by citing them in your text and including a data reference in your Reference List. Data references should include the following elements: author name(s), dataset title, data repository, version (where available), year, and global persistent identifier. Add [dataset] immediately before the reference so we can

properly identify it as a data reference. This identifier will not appear in your published article.

### **Examples:**

*Reference to a book:* Issa ZF, Miller JM, Zipes DP. *Clinical arrhythmology and electrophysiology.* 2nd ed. Philadelphia: Elsevier; 2012.

*Reference to a chapter in an edited book:* Myerburg RJ, Castellanos A. Cardiac arrest and sudden cardiac death. In: Mann DL, Zipes DP, Libby P, Bonow RO, editors. *Heart disease: A textbook of cardiovascular medicine.* 10th ed. Philadelphia: Elsevier; 2015. p. 821-860.

*Reference to a dataset:* [dataset] Oguro M, Imahiro S, Saito S, Nakashizuka T. Mortality data for Japanese oak wilt disease and surrounding forest compositions, *Mendeley Data*, v1; 2015. <http://dx.doi.org/10.17632/xwj98nb39r.1>.

For more than 6 authors, the first 6 should be followed by “et al”. Abbreviate titles of periodicals according to the style of *Index Medicus*, National Library of Medicine. ### **PDF Proofs**

The corresponding author for your article will receive an email containing proofs in PDF format, as well as instructions for reviewing the proofs. Please review these proofs very carefully, as you will not receive a second set. Note also that once an article is published online as an Article in Press, no further corrections can be made except as an erratum or corrigendum; it is therefore imperative that the page proofs be thoroughly reviewed.

### **Additional Online Content**

The journal encourages authors to create an AudioSlides presentation with their published article. AudioSlides are brief, webinar-style presentations that are shown next to the online article on ScienceDirect. This gives authors the opportunity to summarize their research in their own words and to help readers understand what the paper is about. More information and examples are available at <http://www.elsevier.com/audioslides>. Authors will automatically receive an invitation email to create an AudioSlides presentation after acceptance of their paper.

### **Supplementary Material**

TCM Online is able to host other content that is not suitable for print, such as video clips, extensive tables, and supplementary data. We encourage the use of this application.

### **RESEARCH DATA**

This journal encourages and enables you to share data that supports your research publication where appropriate, and enables you to interlink the data with your published articles. Research data refers to the results of observations or experimentation that validate research findings. To facilitate reproducibility and data reuse, this journal also encourages you to share your software, code, models, algorithms, protocols, methods and other useful materials related to the project.

Below are a number of ways in which you can associate data with your article or make a statement about the availability of your data when submitting your manuscript. If you are sharing data in one of these ways, you are encouraged to cite the data in your manuscript and reference list. Please refer to the “References” section for more information about data citation. For more information on depositing, sharing and using research data and other relevant research materials, visit the **research data** page.

#### **Data Linking**

If you have made your research data available in a data repository, you can link your article directly to the dataset. Elsevier collaborates with a number of repositories to link articles on ScienceDirect with relevant repositories, giving readers access to underlying data that gives them a better understanding of the research described.

There are different ways to link your datasets to your article.

#### **Mendeley Data**

This journal supports Mendeley Data, enabling you to deposit any research data (including raw and processed data, video, code, software, algorithms, protocols, and

methods) associated with your manuscript in a free-to-use, open access repository. Before submitting your article, you can deposit the relevant datasets to Mendeley Data. Please include the DOI of the deposited dataset(s) in your main manuscript file. The datasets will be listed and directly accessible to readers next to your published article online. For more information, visit the Mendeley **Data for journals page**.

### Data Statement

To foster transparency, we encourage you to state the availability of your data in your submission. This may be a requirement of your funding body or institution.

If your data is unavailable to access or unsuitable to post, you will have the opportunity to indicate why during the submission process, for example by stating that the research data is confidential. The statement will appear with your published article on ScienceDirect. For more information, visit the **Data statement page**.

### Permissions

In order to reprint a figure or table that has already been published (or modified), the author must secure permission from the copyright holder. Formal permission is not required for Elsevier publications or other STM members but the proper acknowledgment of the original source of publication must be noted in the figure caption.

### Track Your Manuscript Online

After your manuscript has been accepted, you can check the status at <http://www.elsevier.com/locate/trackpaper>. To track your paper, you will need the manuscript reference number from the acknowledgment or receipt email sent to you from Elsevier Production. This number will start with "TCM," followed by a 4-digit number (ex. TCM 5602), and is different than the number assigned to your manuscript during peer review. You will also need to enter the surname of the corresponding author.

### Conflict of Interest

Please refer to the Uniform Requirements for Manuscripts Submitted to Biomedical Journals for ethical considerations (<http://www.icmje.org>). At the time of submission, authors must disclose all relationships that could be viewed as presenting a potential conflict of interest. Conflict of interest exists when an author (or his or her institution) has a financial or personal relationship that could inappropriately influence his or her actions. To prevent

ambiguity, authors must state explicitly whether potential conflicts do or do not exist.

### Declaration of Generative AI in Scientific Writing

The below guidance only refers to the writing process, and not to the use of AI tools to analyse and draw insights from data as part of the research process.

Where authors use generative artificial intelligence (AI) and AI-assisted technologies in the writing process, authors should only use these technologies to improve readability and language. Applying the technology should be done with human oversight and control, and authors should carefully review and edit the result, as AI can generate authoritative-sounding output that can be incorrect, incomplete or biased. AI and AI-assisted technologies should not be listed as an author or co-author, or be cited as an author. Authorship implies responsibilities and tasks that can only be attributed to and performed by humans, as outlined in Elsevier's [AI policy for authors](#).

Authors should disclose in their manuscript the use of AI and AI-assisted technologies in the writing process by following the instructions below. A statement will appear in the published work. Please note that authors are ultimately responsible and accountable for the contents of the work.

### Disclosure Instructions

Authors must disclose the use of generative AI and AI-assisted technologies in the writing process by adding a statement at the end of their manuscript in the core manuscript file, before the References list. The statement should be placed in a new section entitled 'Declaration of Generative AI and AI-assisted technologies in the writing process'.

*Statement: During the preparation of this work the author(s) used [NAME TOOL/SERVICE] in order to [REASON]. After using this tool/service, the author(s) reviewed and edited the content as needed and take(s) full responsibility for the content of the publication.*

This declaration does not apply to the use of basic tools for checking grammar, spelling, references etc. If there is nothing to disclose, there is no need to add a statement.

### Reporting sex- and gender-based analyses

#### Reporting Guidance

For research involving or pertaining to humans, animals or eukaryotic cells, investigators should integrate sex and gender-based analyses (SGBA) into their research design according to funder/sponsor requirements and best practices within a field. Authors should address the sex and/or gender dimensions of their research in their article. In cases where they cannot, they should discuss this as a

limitation to their research's generalizability. Importantly, authors should explicitly state what definitions of sex and/or gender they are applying to enhance the precision, rigor and reproducibility of their research and to avoid ambiguity or conflation of terms and the constructs to which they refer (see Definitions section below). Authors can refer to the [Sex and Gender Equity in Research \(SAGER\) guidelines](#) and the [SAGER guidelines checklist](#). These offer systematic approaches to the use and editorial review of sex and gender information in study design, data analysis, outcome reporting and research interpretation - however, please note there is no single, universally agreed-upon set of guidelines for defining sex and gender.

### Definitions

Sex generally refers to a set of biological attributes that are associated with physical and physiological features (e.g., chromosomal genotype, hormonal levels, internal and external anatomy). A binary sex categorization (male/female) is usually designated at birth ("sex assigned at birth"), most often based solely on the visible external anatomy of a newborn. Gender generally refers to socially constructed roles, behaviors, and identities of women, men and gender-diverse people that occur in a historical and cultural context and may vary across societies and over time. Gender influences how people view themselves and each other, how they behave and interact and how power is distributed in society. Sex and gender are often incorrectly portrayed as binary (female/male or woman/man) and unchanging whereas these constructs actually exist along a spectrum and include additional sex categorizations and gender identities such as people who are intersex/have differences of sex development (DSD) or identify as non-binary. Moreover, the terms "sex" and "gender" can be ambiguous — thus it is important for authors to define the manner in which they are used. In addition to this definition guidance and the SAGER guidelines, [the resources on this page](#) offer further insight around sex and gender in research studies.

### Submission Checklist

Be sure your submission includes the following elements:

- Cover letter – which must include the statement that all authors are responsible for the content and have read and approved the manuscript; and that the manuscript conforms to the Uniform Requirements for Manuscripts Submitted to Biomedical Journals published in *Annals in Internal Medicine*
- Complete manuscript, including:
  - Title page (with authors' complete names, affiliations, and addresses, and telephone/fax numbers and email address of the corresponding author, and please state all conflicts of interest)
  - A substantive, four-sentence abstract
  - Complete main text
  - References (limited to 40)
  - Figure legends
  - Tables and figures
- Conflict of interest form
- Permission for use of copyrighted material
- A list of three potential peer reviewers along with their contact information
